- 4. Pre-bid meeting shall be held Jorayal Rural Municipality, Rautkatte Doti at 12:00 pm on 2077/02/15 (May. 28<sup>th</sup>, 2020)
- 5. Sealed bids must be submitted to Jorayal Rural Municipality Office, Rautkatte, Doti, by hand/courier on before 12:00 Noon on 2077/02/21 (June. 3<sup>rd</sup>, 2020). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2077/02/21 (June. 3<sup>rd</sup>, 2020) at the office of Jorayal Rural Municipality, Rautkatte, Doti. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security amounting to a minimum of 2.5% of the Total Project Cost including VAT, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 8. In case of discrepancy or error in Tender notice, bid document and other document of Construction of Ayurveda Office Building mentioned above reserves right to amend, correct at any time.
